Election Judge Qualifications and Duties

Qualifications - 115.085 RSMO

- Must be a registered voter in Cass County.
- A Person of good repute and character.
- A Person who can speak, read and write the English language.
- Cannot hold public office except a political party committee.
- Pursuant to Section 115.085 RSMO 1986, no election judge shall be related within the second degree by blood or marriage to a contested candidate on the ballot at the polling place that the election judge is working.

Duties -

If any Election Judge or Poll worker violates this law for the current election please call 816-380-8102.

- Hours are 5:00 a.m. until the polls close and your duties complete around 8 p.m.
- Each precinct has two Presiding Judges (1- Democrat & 1-Republican) and other equal amounts as deemed necessary by the Election Authority.
- On Election Day Presiding Judges along with Regular Judges are responsible for assisting with the election process at the polls.
- Presiding Judges are responsible for the return of ballots and supplies on election night in a timely fashion.
- Presiding Judge pay is \$135.00 a day plus \$10.00 for mileage for whomever drives to the courthouse election night. Regular Judge pay is \$125.00 a day.
- There will be training sessions before each election for Election Judges and each person will receive \$30.00 for training.
