



## Update Regarding COVID-19 Vaccine

### COVID-19 Vaccine Supply and Availability

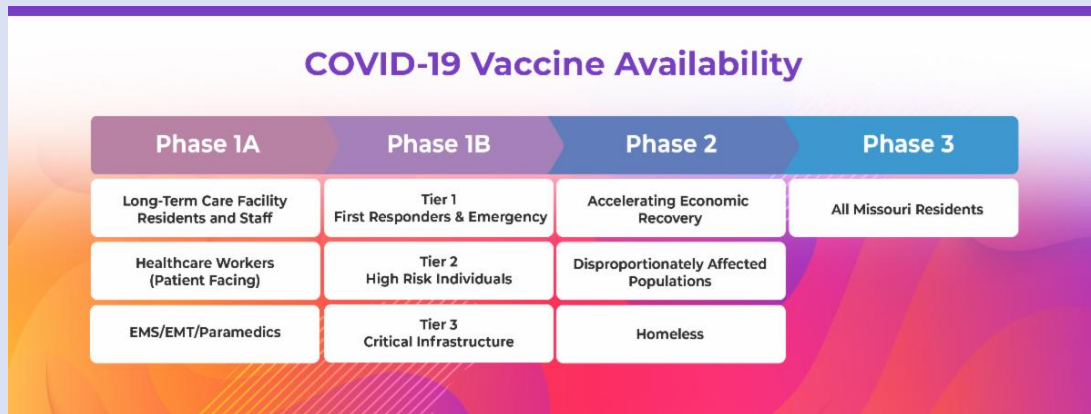


Figure 1: COVID-19 Vaccine Availability <https://covidvaccine.mo.gov/>

Missouri is currently vaccinating individuals in Phase 1A, Phase 1B - Tier 1, and Phase 1B - Tier 2, Phase 1B - Tier 3, and Phase 2 [see **Figure 1**]. Phase 3 will open on Friday, April 9, 2021, which will allow for all remaining Missouri residents to become eligible for vaccination. CCHD is one of several vaccinators in Cass County. We are collaborating with Cass Regional Medical Center, Belton Regional Medical Center, and Compass Health. We are providing individuals on our vaccine interest list with vaccination opportunities sponsored by these agencies as they become available.

### Vaccine Demand

CCHD initiated a vaccine interest survey on January 6, 2021. Since that time, over 36,000 people have signed up wanting vaccine. This information is being used to prioritize individuals to the correct tier and direct them to vaccine opportunities as they become available.

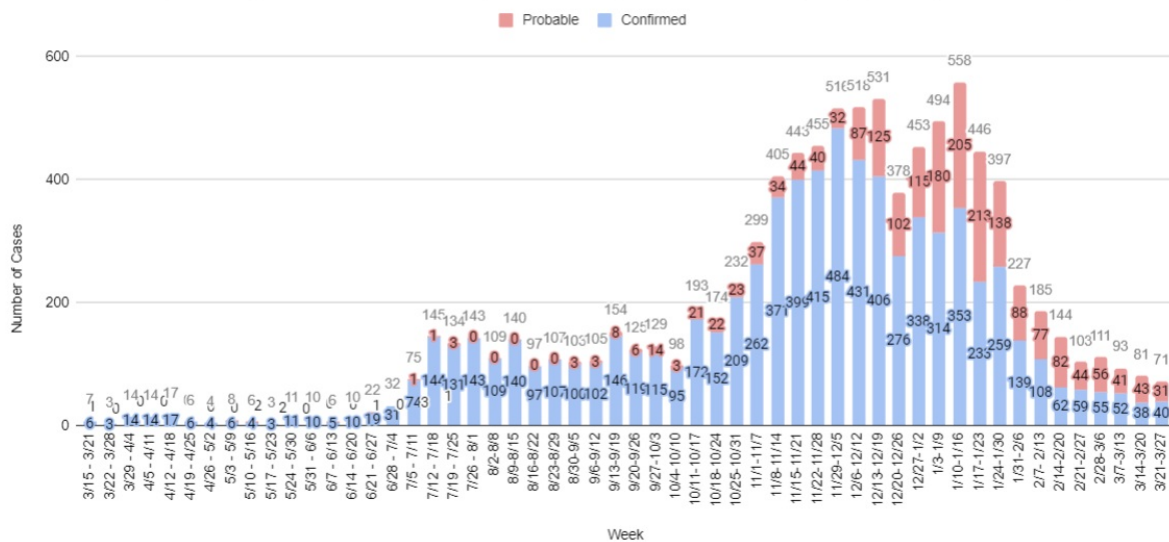
