Personal Service:

Costs for Service by Sheriff's Office are based on service address.

If service address is in Cass County:

Cass County Sheriff \$30.00 Plus Mileage (varies) To obtain amount owed, call 816-380-8320

Make money order **payable to Cass County Sheriff**, and bring to Cass County Circuit Clerk's Office with filing paperwork

If service address is in another county:

Contact Sheriff's office in the other county and ask for their cost of service. They will need the service address.

Make money order **payable to that county's Sheriff**, and bring to Cass County Circuit Clerk's Office with filing paperwork
